SUPREMATISM AND CONSTRUCTIVISM

RUSSIAN ARTISTS LIKE KAZIMIR MALEVICH AND EL LISSITZKY EXPLORED PURE ABSTRACTION THROUGH BASIC GEOMETRIC FORMS AND A FOCUS ON VISUAL PURITY. SUPREMATISM EMPHASIZED SPIRITUAL TRANSCENDENCE, WHILE CONSTRUCTIVISM COMBINED ABSTRACTION WITH UTILITARIAN DESIGN.

DE STIJL

FOUNDED BY PIET MONDRIAN, DE STIJL ADVOCATED FOR HARMONY AND ORDER THROUGH PURE ABSTRACTION, USING STRAIGHT LINES AND PRIMARY COLORS. THIS MOVEMENT INFLUENCED ARCHITECTURE, DESIGN, AND ART WORLDWIDE.

ABSTRACT EXPRESSIONISM

IN POST-WAR AMERICA, ABSTRACT EXPRESSIONISM BECAME SYNONYMOUS WITH SPONTANEOUS, EMOTIVE PAINTING. ARTISTS SUCH AS JACKSON POLLOCK AND MARK ROTHKO PRIORITIZED THE CREATIVE PROCESS ITSELF, RESULTING IN HIGHLY INDIVIDUALISTIC WORKS.

Among the numerous intellectual and artistic developments set in a new light by this brilliantly wide-ranging book are: the long line of philosophical and theoretical writing on rhythm, from Nietzsche to Bergson and their twentieth-century interlocutors; psychological explorations of rhythm as the fundamental law of life, from Herbert Spencer and Ralph Waldo Emerson to Elsie Fogarty; more experimental engagements with psychology's rhythms, from Wilhelm Wundt, Théodule Ribot, and Karl Groos to the aesthetic writings of Vernon Lee; the history of prosody; pioneering applications of rhythm studies to social and sexual reform, by Havelock Ellis, Marie Stopes, D. H. Lawrence, and Mary Austin (among others); Lebensreform movements and the contribution of Rudolf Steiner and Emile Jaques-Dalcroze; and numerous endeavours in artistic and critical innovation, from the small modernist magazines of Bloomsbury and Paris to art salons and dance studios across Britain, Continental Europe, and America.

Topical issues of interest for practitioners, academics, and students of arbitration include the following: legitimacy and authority of arbitrators, institutions and professional organizations to act as lawmakers; investment treaty reform, with particular reference to the definition of 'investment,' the evolution of substantive treaty standards, and sustainable development obligations; commercial arbitration reform, including issues of public and private interest, the development of common law, and cost, delay and transparency concerns; revisiting party autonomy in choosing decision-makers, including through institutional appointments or investment courts; equality of arms, the economics of access, and the role of costs and third-party funding; public-private disputes and special issues that arise when State entities arbitrate; public participation and transparency, and their effect on both ISDS and commercial arbitration; revisiting conventional wisdom in organizing arbitral proceedings; lessons to be learned from other dispute resolution frameworks; technology as friend and enemy, including new tools, new threats, and cybersecurity; arbitration of disputes in conflict and post-conflict zones; inter-generational blame and praise in investment arbitration; and the emergence of sovereign wealth funds as arbitration participants. A special section on 'New Frontiers in Arbitration' offers enlightening perspectives on new types of claims and new types of stakeholders likely to affect the future of international arbitration, including the potential for climate change disputes and enlarged participation.
