SCHOOL SAFETY AND SECURITY MEASURES

EVOLUTION OF SECURITY PROTOCOLS

SINCE THE COLUMBINE TRAGEDY, SCHOOLS ACROSS THE UNITED STATES HAVE SIGNIFICANTLY ENHANCED THEIR SECURITY MEASURES. THE EVENT HIGHLIGHTED VULNERABILITIES IN EXISTING PROTOCOLS, PROMPTING DISTRICTS TO INVEST IN NEW TECHNOLOGIES AND PROCEDURES. ROLE OF SCHOOL RESOURCE OFFICERS (SROs)

ONE MAJOR CHANGE FOLLOWING COLUMBINE WAS THE INCREASED PRESENCE OF SCHOOL RESOURCE OFFICERS (SROs) IN EDUCATIONAL SETTINGS. SROs ARE LAW ENFORCEMENT PROFESSIONALS ASSIGNED TO SCHOOLS TO DETER VIOLENCE, RESPOND TO INCIDENTS, AND BUILD RELATIONSHIPS WITH STUDENTS. THEIR ROLE EXTENDS BEYOND SECURITY, INCLUDING MENTORSHIP, EDUCATION ON SAFETY TOPICS, AND MEDIATION OF CONFLICTS. THE IMPACT OF COLUMBINE IS EVIDENT IN THE WIDESPREAD ADOPTION OF SRO PROGRAMS, WHICH SERVE AS A CORE COMPONENT OF CONTEMPORARY SCHOOL SAFETY STRATEGIES.

TECHNOLOGICAL ADVANCEMENTS IN SECURITY
