STEPS TO CONDUCT A COMPREHENSIVE SOCIAL WORK LITERATURE REVIEW

CONDUCTING A COMPREHENSIVE SOCIAL WORK LITERATURE REVIEW INVOLVES SEVERAL KEY STEPS TO ENSURE RIGOR AND RELEVANCE.

4. SCREEN AND SELECT RELEVANT STUDIES

When writing the social work literature review, ensure clarity, logical flow, and comprehensive coverage of themes. Use clear headings, concise language, and evidence to support all claims. Incorporate both direct quotations and paraphrased material where appropriate, always citing sources accurately.
